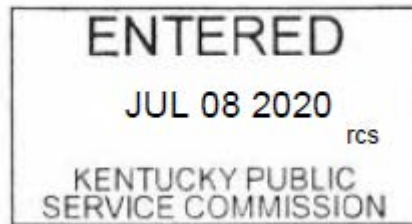
Having considered the motion and being otherwise sufficiently advised, the Commission finds good cause to schedule an informal conference on Wednesday, July 8, 2020.
