## <u>order</u>

This matter arises upon motions filed by Delta Natural Gas Company, Inc. (Delta) Kentucky Power Company (Kentucky Power), Louisville Gas and Electric Company (LG&E), and Kentucky Utilities Company (KU) (jointly LG&E/KU) requesting an extension of time to file an annual report containing utility-specific information set forth in Appendix B (Annual Report) to the Commission's May 4, 2020 Order in this proceeding.

Delta requested an extension until July 31, 2020, to file the Annual Report because some information contained in the Annual Report will not be available until that date. Kentucky Power and LG&E/KU respectively requested an extension until August 14, 2020, because each interpreted the May 4, 2020 Order to require the Annual Report to be filed on July 15, 2021, and not July 15, 2020.

Based upon the motions and being otherwise sufficiently advised, the Commission finds that Delta, Kentucky Power, and LG&E/KU established good cause to grant their motions. The Commission further finds that an extension until August 15, 2020, should be provided to all utilities required to file the Annual Report. Given that three of the parties interpreted the May 4, 2020 Order to establish a filing date in 2021, it is a reasonable conclusion that other parties may have drawn the same conclusion. For reasons of

administrative efficiency and equity, the Commission finds good cause to extend the filing date for the Annual Report from July 15, 2020, to August 15, 2020.

IT IS THEREFORE ORDERED that:

1. Delta's, Kentucky Power's, and LG&E/KU's motions for an extension to file the Annual Report are granted.

2. Delta, Kentucky Power, LG&E/KU, Columbia Gas of Kentucky, Inc., and Duke Energy Kentucky, Inc. shall file their respective Annual Reports on or before August 15, 2020.
