ORDER

On December 23, 2019, Delta Natural Gas Company, Inc. (Delta) filed its proposed Gas Cost Recovery (GCR) report to be effective January 27, 2020.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Delta's GCR report includes revised rates designed to pass on to its customers its expected change in gas costs.
2. Delta's GCR report sets out an Expected Gas Cost (EGC) of \$3.4088 per Mcf, which is a decrease of \$.0550 per Mcf from the previous EGC of \$3.4638 per Mcf.
3. Delta's GCR report sets out no Refund Adjustment.
4. Delta's GCR report sets out a current quarter Actual Adjustment (AA) of \$.3138 per Mcf. Delta's total AA is \$.9952 per Mcf, which is a decrease of \$.1360 per Mcf from the previous total AA of \$1.1312 per Mcf.
5. Delta's GCR report sets out a current quarter Balance Adjustment (BA) of (\$.0081) per Mcf. Delta's total BA is (\$.2351) per Mcf, which is an increase of \$.0274 per Mcf from the previous total BA of (\$.2625) per Mcf.

6. Delta's GCR rate is \$4.1689 per Mcf, which is a decrease of \$.1636 per Mcf from the previous GCR rate of \$4.3325 per Mcf.

7. The rates as proposed by Delta and set forth in the Appendix to this Order are fair, just, and reasonable and should be approved for final meter readings by Delta on and after January 27, 2020.


IT IS THEREFORE ORDERED that:

1. The rates proposed by Delta and set forth in the Appendix to this Order are approved for final meter readings on and after January 27, 2020.


