Pursuant to 807 KAR 5:056, the Commission, on February 11, 2019, established this case to review and evaluate the application of the Fuel Adjustment Clause (FAC) of Jackson Purchase Energy Corporation, Kenergy Corp., and Meade County Rural Electric Cooperative Corporation (collectively Cooperatives or individually Cooperative) for the two-year period from November 1, 2016, through October 31, 2018.

As part of this review, the Commission ordered each Cooperative to individually submit certain information and an affidavit attesting to its adherence to 807 KAR 5:056. The Commission further ordered that a public hearing be held in this case but cancelled it when, after publication of notice, no interested person advised the Commission of intent to attend. There are no intervenors in this proceeding.

During the period under review, the Cooperatives have complied in all material respects with the provisions of 807 KAR 5:056. As Big Rivers Electric Corporation, the wholesale supplier of the Cooperatives, has been authorized to maintain its base fuel rate

at its current level¹, the Commission finds that each individual Cooperatives' proposal to maintain rates at the current level should be approved.

IT IS THEREFORE ORDERED that:

1. The charges and credits applied by each individual Cooperative through the FAC for the period from November 1, 2016, through October 31, 2018, are approved.

2. Each individual Cooperative's proposal to maintain its rates at the current level is approved.
