ORDER

Based on the requirements of the streamlined rate procedure, IT IS THEREFORE ORDERED that:

1. The Attorney General is granted intervention in this proceeding.

 Within seven days of the date of entry of this Order the Attorney General shall file with the Commission either:

a. A statement as required by 807 KAR 5:001, Section 8(9)(b); or

b. A statement that the Attorney General will not participate in this proceeding.
