## ORDER

On March 28, 2019, Jackson Energy Cooperative Corporation (Jackson Energy), pursuant to the "streamlined procedure" established in Case No. 2018-00407,<sup>1</sup> filed an application seeking a general adjustment in its rates. Under the procedure established in Case No. 2018-00407,<sup>2</sup> the Commission, upon receipt of an application, is to issue an Order that, *inter alia*, grants the Attorney General of the Commonwealth of Kentucky, through the Office of Rate Intervention (Attorney General), intervention in the case and establishes a deadline for filing of comments in the record regarding whether the application should be processed under the streamlined procedure. Based on the requirements of the streamlined rate procedure, IT IS THEREFORE ORDERED that:

1. The Attorney General is granted intervention in this proceeding.

2. Within seven days of the date of entry of this Order the Attorney General shall file with the Commission either:

a. A statement as required by 807 KAR 5:001, Section 8(9)(b); or


