ORDER

On March 29, 2019, Louisville Gas and Electric Company (LG&E), filed its proposed Gas Supply Clause (GSC) report to be effective May 1, 2019.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

- LG&E's report includes revised rates designed to pass on to its customers its expected change in gas costs.
- LG&E's report sets out a Gas Supply Cost of \$.37871 per 100 cubic feet, or \$3.7871 per Mcf, which is a decrease of \$.2838 per Mcf from the previous Gas Supply Cost of \$4.0709 per Mcf.
 - LG&E's report sets out no Refund Factor.
- 4. LG&E's report sets out a current Gas Cost Actual Adjustment (GCAA) of \$.4305 per Mcf and a total GCAA of \$.5148 per Mcf, which is an increase of \$.4339 per Mcf from the previous total GCAA of \$.0809 per Mcf.
- LG&E's report sets out a Gas Cost Balance Adjustment (GCBA) of (\$.0036)
 per Mcf, which is an increase of \$.0013 per Mcf from the previous GCBA of (\$.0049) per

 Mcf.
- LG&E's report sets out a Performance-Based Rate Recovery Component
 (PBRRC) of \$.0635 per Mcf, which is no change from its previous PBRRC.

- LG&E's Gas Supply Cost Component (GSCC) is \$.43618 per 100 cubic feet
 or \$4.3618 per Mcf, which is an increase of \$.1514 per Mcf from the prior GSCC of
 \$4.2104 per Mcf.
- 8. The rate as proposed by LG&E and set forth in the Appendix to this Order is fair, just, and reasonable, and should be approved for gas supplied by LG&E on and after May 1, 2019.

IT IS THEREFORE ORDERED that:

- The rate proposed by LG&E and set forth in the Appendix to this Order is approved for gas supplied by LG&E on and after May 1, 2019.
- Within 20 days of the date of entry of this Order, LG&E shall file with this
 Commission, using the Commission's electronic Tariff Filing System, revised tariff
 sheets setting out the rate approved herein and reflecting that it was approved pursuant to this Order.
 - 3. This case is closed and removed from the Commission's docket.
