## NOTICE OF ELECTION OF USE OF ELECTRONIC FILING PROCEDURES

(Complete All Shaded Areas and Check Applicable Boxes)

In accordance with 807 KAR 5:001, Section 8, <u>East Kentucky Power Cooperative, Inc.</u> gives notice of its intent to file an application for <u>its 2019 Integrated Resource Plan</u> with the Public Service Commission no later than <u>April 1, 2019</u> and to use the electronic filing procedures set forth in that regulation.

East Kentucky Power Cooperative, Inc. further states that:

- 1. It requests that the Public Service Commission assign a case number to the intended application and advise it of that number as soon as possible;
- 2. It or its authorized representatives have registered with the Public Service Commission and X are authorized to make electronic filings with the Public Service Commission;
- 3. Neither it nor its authorized representatives have registered with the Public Service Commission for authorization to make electronic filings but will do so no later than seven days before the date of its filing of its application for rate adjustment;
