1. The procedural schedule in the July 5, 2019 Order is stricken and replaced with the amended procedural schedule attached as an appendix to this Order.



At the time the notice is mailed or publication is requested, EKPC shall forward a duplicate of the notice and request to the Commission. 4. Pursuant to KRS 278.360 and 807 KAR 5:001, Section 9(9), a digital video transcript shall be made of the hearing.

5. On or before July 15, 2020, Commission Staff shall schedule an informal conference with the parties for the purpose of discussing the scope of the hearing and identifying witnesses who will offer testimony at the August 20, 2020 hearing.
