ORDER

By Order issued November 23, 2020, the Commission entered into the record of this proceeding a report summarizing Commission Staff's review (Staff Report) of the 2019 Integrated Resource Plan (IRP) filed by East Kentucky Power Cooperative, Inc. (EKPC), pursuant to 807 KAR 5:058. By Order issued December 7, 2020, the Commission granted EKPC ten days to file comments on the Staff Report. On December 16, 2020, EKPC filed its comments into the record of this proceeding.
