ORDER

On March 29, 2019, Columbia Gas of Kentucky, Inc. (Columbia Kentucky), submitted revised Accelerated Main Replacement Program (AMRP) tariff rate, with an effective date of May 31, 2019, based on Columbia Kentucky's annual balancing adjustment calculation to true-up the actual AMPR costs for the 12 months ended December 31, 2018. Pursuant to an Order entered April 10, 2019, the AMRP Rider was suspended up to and including October 30, 2019. Columbia Kentucky responded to one request for information issued by Commission Staff. There are no intervenors in this proceeding. The case now stands submitted for a decision.

Columbia Kentucky's 2018 AMRP revenue requirement is \$3,805,914.¹ During 2018, Columbia Kentucky had an over recovery of \$633,725. Columbia Kentucky proposes to reduce its AMRP rates to reflect amounts over recovered from its customers through its AMRP balancing adjustment for 2019.

Having reviewed the evidence of record and being otherwise sufficiently advised, the Commission finds that the information contained in Columbia Kentucky's application, along with its responses to the requests for information, is in sufficient detail to support

the reasonableness of Columbia Kentucky's proposed AMRP Rider rates, which have been reduced from previous amounts by \$633,725 to include the 2018 over-recovered amounts.

IT IS THEREFORE ORDERED that:

- The AMRP rates in the Appendix to this Order are approved for service rendered by Columbia Kentucky on and after the date of this Order.
- 2. Within 20 days of the date of this Order, Columbia Kentucky shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets setting out the rates approved and reflecting that they were approved pursuant to this Order.
 - 3. This case is now closed and removed from the Commission's docket.
