## ORDER

On July 11, 2019, the Attorney General of the Commonwealth of Kentucky, by and through the Office of Rate Intervention (Attorney General), filed a motion requesting a one-day extension of time, from July 11, 2019, to July 12, 2019, to file a request for commitments to the Joint Applicants. As grounds for the motion, the Attorney General states that the additional day is needed due to the time and resources that were diverted from this case to the three days of Commission hearings involving water utilities during the week of July 7, 2019. The motion also states that the Joint Applicants have no objection to the one-day extension of time as long as the due date for their response is extended by one day, from July 18, 2019, to July 19, 2019. The Attorney General tendered for filing the request for commitments to the Joint Applicants on July 12, 2019.

Based on a review of the motion and finding good cause, the Commission HEREBY ORDERS that:

1. The Attorney General's motion for a one-day extension of time is granted.

- The Attorney General's tendered request for commitments to the Joint Applicants is accepted for filing as of July 12, 2019.
- The Joint Applicants shall file a response to the Attorney General's request for commitments to the Joint Applicants on or before July 19, 2019.
