## ORDER

A formal complaint was filed by Sarah Sperry (Ms. Sperry), through her counsel Attorney Matthew J. Baker (Attorney Baker), against Atmos Energy Corporation (Atmos) on April 29, 2019, with the Commission. However, Attorney Baker filed a notice of withdrawal as counsel (Notice of Withdrawal) on August 12, 2019, and asserted that all further contact and communication with regard to this matter should be directed to Ms. Sperry.<sup>1</sup>

Due to Attorney Baker's Notice of Withdrawal, the Commission finds good cause to hold this case in abeyance for 30 days in order to allow Ms. Sperry to either obtain new counsel or indicate that she intends to represent herself pro se in the pending complaint proceeding. After the 30-day abeyance period, the Commission will address the pending pleadings that are currently before it.
