ORDER

On July 11, 2019, East Kentucky Power Cooperative, Inc. (EKPC) filed a motion requesting an extension of time in which to file its responses to the discovery requests of Commission Staff, Nucor Steel Gallatin, and the Office of the Attorney General. EKPC states that the responses are due by July 12, 2019. However, due to the unavailability of relevant personnel and other pressing obligations, EKPC is not able to fully prepare the responses to all the information requests as of July 11, 2019. EKPC requests a brief extension until July 17, 2019, to submit its responses. EKPC states that the requested extension would not negatively impact the existing procedural schedule, but is agreeable to amending the current schedule to allow Commission Staff and intervenors a corresponding period of additional time to file supplemental information requests.

Having reviewed the motion and being otherwise sufficiently advised, the Commission finds that EKPC has established good cause to permit it a brief extension of time to file its responses to the first sets of discovery requests. The Commission also finds that the current procedural schedule should be amended to allow for additional time for the other parties to file supplemental information requests.

IT IS HEREBY ORDERED that:

1. EKPC's motion for an extension of time is granted.
2. EKPC shall file its responses to initial requests for information no later than July 17, 2019.
3. The procedural schedule set forth in the Appendix to this Order shall be followed in this proceeding.
4. All other provisions of the Commission's May 21, 2019 Order not inconsistent with this Order shall remain in full force and effect.
