ORDER

On May 21, 2019, Millennium Energy, Inc. (Millennium), filed its proposed Gas Cost Recovery (GCR) rate report to be effective July 1, 2019. After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

- Millennium's report includes revised rates designed to pass on to its customers its expected change in gas costs.
- Millennium's report sets out an Expected Gas Cost (EGC) of \$3.2257 per
 Mcf, which is a decrease of \$.0267 per Mcf from its previous EGC of \$3.2524 per Mcf.
 - 3. Millennium's report sets out no supplier Refund Adjustment.
- 4. Millennium's report sets out a current quarter Actual Adjustment (AA) of (\$.1369) per Mcf. Millennium's total AA is (\$.0274) per Mcf, which is a decrease of \$.0523 per Mcf from its previous total AA of \$.0249 per Mcf.
- 5. Millennium's report sets out a current quarter Balance Adjustment (BA) of (\$.0072) per Mcf. Millennium's total BA is \$.0026 per Mcf, which is an increase of \$.0097 per Mcf from its previous total BA of (\$.0071) per Mcf.
- 6. Millennium's GCR rate is \$3.2009 per Mcf, which is a decrease of \$.0693 per Mcf from the previous GCR rate of \$3.2702 per Mcf.

 The rates proposed by Millennium and set forth in the Appendix to this Order are fair, just, and reasonable and should be approved for service rendered by Millennium on and after July 1, 2019.

IT IS THEREFORE ORDERED that:

- The rates proposed by Millennium and set forth in the Appendix to this Order are approved for service rendered on and after July 1, 2019.
- 2. Within 20 days of the date of entry of this Order, Millennium shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets setting out the rates approved herein and reflecting that they were approved pursuant to this Order.
 - 3. This case is closed and removed from the Commission's docket.
