FOR RESPONSE TO NOTICE OF FILING DEFICIENCY**


New Cingular Wireless PCS, LLC, a Delaware Limited Liability Company, d/b/a AT&T Mobility ("Applicant"), by counsel and in response to the Commission's letter dated July 11, 2019 requesting additional information to cure deficiencies identified by the Commission Staff in the within matter, states as follows:

1. Applicant timely filed its initial Response to the Commission's information request on July 17, 2019 and requested for Commission to extend the time for Applicant to submit additional responsive information.
2. By Order of the Commission entered July 25, 2019, the Commission granted Applicant's request and extended the time for Applicant to submit responsive information to the Commission through August 5, 2019
3. With respect to the Commission Staff's specific request for information pursuant to 807 KAR 5:063: Section 1(1)(d), Applicant has determined that additional time

will be required to conduct necessary on-site investigations, to complete analysis of relevant data, and to obtain appropriate documentation from the proposed tower manufacturer to respond fully and completely, and Applicant respectfully requests for Commission to hold this matter in abeyance until Applicant is able to complete said due diligence and file the resulting documentation as an amendment to its application for Certificate of Public Convenience and Necessity.

**WHEREFORE**, Applicant respectfully request that the PSC accept the foregoing Response for filing and enter all necessary docket notations or Orders to extend the time for further Response and hold this matter in abeyance pending amendment of the subject application by Applicant as requested herein.
