<u>ORDER</u>

On May 28, 2020, a final Order was issued in this matter approving Kentucky Power Company's application for a Certificate of Public Convenience and Necessity related to improvements and upgrades at the company's Wooton and Hazard Substations. Upon further review of the May 28, 2020 Order, the Commission finds that there is a clerical error on page 10. Specifically, the first partial sentence at the top of page 10 incorrectly references "Baseline Projects submitted by Transmission Owners." The reference to "Baseline Projects" should have referred to "Supplemental Projects."

IT IS HEREBY ORDERED, nunc pro tunc, that:

- 1. The partial sentence at the top of page 10 of the May 28, 2020 Order shall be revised to state as follows: "process still has shortcomings such as PJM not having to approve or deny Supplemental Projects submitted by Transmission Owners."
- 2. All other provisions of the May 28, 2020 Order that are not in conflict with the terms of this Order shall remain in full force and effect.
