Investigation Summary:

I talked with Burl Russell on 9/25/18 at 12:48pm. He stated that the landowner called in the 811 ticket and he did not have an updated ticket with the reasoning the lines were not going to be moved in the mean time. He stated that the gas line was only buried 3-4 inches deep in the soil and he should not be held responsible. PSC is going to reduce the fine from \$1250 to \$250 and offer remedial measures. Mr. Russell may not be inclined to pay the \$250 penalty or seek the remedial measure. He was reiterated the process that was available to contest the penalty.
