ORDER

On June 24, 2019, Peoples Gas KY, LLC (Peoples), filed its proposed Gas Cost Recovery (GCR) rate report to be effective August 1, 2019.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

- Peoples' GCR report includes a revised rate designed to pass on to its customers its expected change in gas costs.
- Peoples' GCR report sets out an Expected Gas Cost (EGC) of \$3.6574 per
 Mcf, which is a decrease of \$.9692 per Mcf from its previous EGC of \$4.6266 per Mcf.
 - Peoples' GCR report sets out no Refund Adjustment.
- 4. Peoples' GCR report sets out a current quarter Actual Cost Adjustment (ACA) of (\$.3028) per Mcf. Peoples' total ACA is (\$.0313) per Mcf, which is a decrease of \$1.1488 per Mcf from the previous total ACA of \$1.1175 per Mcf.
- Peoples' GCR report sets out a current quarter Balance Adjustment (BA) of \$.0155 per Mcf. Peoples' total BA is (\$.0138) per Mcf, which is a decrease of \$.0070 per Mcf from the previous total BA of (\$.0068) per Mcf.

- Peoples' GCR rate is \$3.6123 per Mcf, which is a decrease of \$2.1250 per
 Mcf from its previous rate of \$5.7373 per Mcf.
- 7. The rate as proposed by Peoples and set forth in the Appendix to this Order is fair, just, and reasonable, and should be approved for final meter readings by Peoples on and after August 1, 2019.

IT IS THEREFORE ORDERED that:

- The rate proposed by Peoples and set forth in the Appendix to this Order is approved for final meter readings on and after August 1, 2019.
- Within 20 days of the date of entry of this Order, Peoples shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets setting out the rate approved herein and reflecting that it was approved pursuant to this Order.
 - 3. This case is closed and removed from the Commission's docket.
