ORDER

Pursuant to 807 KAR 5:056, the Commission established this case on August 12, 2019, to review and evaluate the operation of the Fuel Adjustment Clause (FAC) of Louisville Gas and Electric Company (LG&E) for the six months that ended on April 30, 2019. As part of this review, LG&E responded to a request for information. The Commission scheduled a formal hearing in this matter for October 15, 2019, but canceled the hearing after finding that, pursuant to 807 KAR 5:056 Section 3(4)(b), a hearing in this matter was not necessary to protect a substantial interest nor otherwise in the public interest.

A review of LG&E's monthly FAC filings shows that the fuel cost billed for the six months under review ranged from a low of \$0.02362 per kWh in April 2019 to a high of \$0.02572 per kWh February 2019 with a six-month average of \$0.02505 per kwh.

Having considered the evidence of record and being otherwise sufficiently advised, the Commission finds no evidence of improper calculation or application of LG&E's FAC charges or improper fuel procurement practices.

IT IS THEREFORE ORDERED that:

- The charges and credits billed by LG&E through its FAC for November 1,
 2018, through April 30, 2019, are approved.
 - 2. This case is closed and removed from the Commission's docket.
