ORDER

On September 12, 2019, the Commission issued an Order approving the purchased water adjustment of Magoffin County Water District (Magoffin District). On October 3, 2019, Magoffin District's superintendent filed a letter indicating that Magoffin District identified an error in the rates in its application that were approved in the September 12, 2019 Order. Specifically, Magoffin District indicated that it determined its rate by applying the purchase water adjustment factor of \$.20 per thousand gallons to a rate that was effective October 15, 2015, as opposed to its current rate approved in an Order in Case No. 2017-00269. The effect was that the purchased water adjustment factor of \$.10 per thousand gallons approved in Case No. 2017-00269 was not reflected in the final rate approved in this matter. Thus, the Commission, on its own motion, finds that Appendix B to the September 12, 2019 Order lists incorrect rates, and the corrected Appendix B attached hereto should be substituted for the Appendix B in that Order.

IT IS THEREFORE ORDERED, nunc pro tunc, that:

 Appendix B to the Commission's September 12, 2019 Order is stricken and replaced by the corrected Appendix B attached to this Order.
