ORDER

The matter is before the Commission upon a motion filed by the city of Henderson and the Henderson Utility Commission d/b/a Henderson Municipal Power & Light (jointly Henderson) requesting that the informal conference currently scheduled for February 27, 2020, be rescheduled. In support of the motion, Henderson states that the General Manager for the utility has a conflict with the date as scheduled as he will be in Washington, D.C., for a legislative meeting. Big Rivers Electric Corporation (BREC) filed a response, indicating that it does not object to rescheduling the informal conference but recommends that the informal conference be rescheduled for either March 5, 2020, or March 6, 2020, as BREC's representatives are available on those dates.
