RE: Informal Conference of March 5, 2020

Pursuant to an Order issued on February 28, 2020, an informal conference (IC) was held at the Commission's offices in Frankfort, Kentucky, on March 5, 2020. The IC was held at the request of Big Rivers Electric Corporation (BREC) to allow the parties an opportunity to discuss and clarify the issues and the possible resolution of issues in this proceeding. The attendance sheet for the IC is attached to this memo.

Representatives of BREC began the discussions by providing a power point presentation that detailed the history among BREC, the city of Henderson, and the Henderson Utility Commission d/b/a Henderson Municipal Power & Light (HMP&L) with respect to the operation of HMP&L's Station Two Generating Station pursuant to the various agreements related to the construction, operation, and use of the Station Two facilities and the parties' obligations under those agreements. BREC's presentation also included an offer of settlement and BREC provided details to those particular terms of offer.1 Representatives of the city of Henderson indicated their objections to certain characterizations made by BREC concerning the contractual relationship and obligations among the parties with respect to the operation and use of Station Two. The city of Henderson further indicated that it would need time to review and respond to the offer made by BREC. With respect to the procedural deadlines proposed by BREC, the city of Henderson stated that it will provide alternative dates to consider and would do so by March 13, 2020.

There being no further discussion, the IC was then adjourned.
