# CITY OF HENDERSON, KENTUCKY AND HENDERSON UTILITY COMMISSION, d/b/a HENDERSON MUNICIPAL POWER & LIGHT'S MOTION TO CONVERT CASE TO ALLOW FOR ELECTRONIC FILING PROCEDURES

The City of Henderson, Kentucky, and the Henderson Utility Commission, d/b/a Henderson Municipal Power & Light (jointly referenced hereinafter as "Henderson"), by counsel, and pursuant to 807 KAR 5:001, Section 8, hereby move the Kentucky Public Service Commission to convert the above-styled case to an electronic case. In support of this Motion,

- 1. Henderson and the undersigned counsel have reviewed the electronic filing procedures regulation and are capable of sending and receiving electronic transmissions.
- 2. Big Rivers is capable of sending and receiving electronic transmissions, as evidenced by its inclusion of electronic mail addresses in the signature line of its application and its practice of serving courtesy copies of pleadings filed in this action upon Henderson via electronic mail.
- 3. Neither party will be adversely affected by converting the case so as to implement electronic filing procedures.

4. An electronic case provides for a more efficient filing process through reduced costs of compliance and additional filing time and the conversion to an electronic case aligns with the Commission's current preference for electronic filing procedures.
