## ORDER

The matter is before the Commission upon a motion filed on October 3, 2019, by Duke Energy Kentucky, Inc. (Duke Kentucky), pursuant to 807 KAR 5:001, Section 4(5), requesting leave to file, without delay, an errata sheet to the Direct Testimony of Melissa B. Abernathy, which was originally filed on September 3, 2019. In support of its motion, Duke Kentucky states that while in the course of preparing its responses to Commission Staff's First Request for Information, Duke Kentucky discovered an inadvertent typo contained in Ms. Abernathy's direct testimony on page 8, lines 9–12. Specifically, the change corrects the amount of the four asset retirement obligations as of June 30, 2019, to reflect \$24.3 million rather than the \$4.3 million amount as originally provided in Ms. Abernathy's direct testimony.

Having reviewed the motion and being otherwise sufficiently advised, the Commission finds that Duke Kentucky established good cause to permit it to file the correction to Ms. Abernathy's direct testimony.

IT IS THEREFORE ORDERED that Duke Kentucky's motion for leave to file	a
