## ORDER

On October 16, 2020, an Order was issued in this matter addressing Duke Energy Kentucky, Inc.'s (Duke Kentucky) petition for rehearing on the merits. Upon further review of the October 16, 2020 Order, the Commission finds that there is a clerical error on page 5 of 13 of Appendix B. Specifically, the Rate Appendix as set forth in Appendix B on page 5 of 13 incorrectly references a rate of \$36.80 for the 7,000 Lumen (Gas Replica) street lighting fixture under the Decorative Fixture – Mercury Vapor heading. The rate should have been stated as \$23.64 for the 7,000 Lumen (Gas Replica) street lighting fixture.

Finding that the October 16, 2020 Order should be amended, the Commission HEREBY ORDERS, *nunc pro tunc*, that:

1. The rate associated with the 7,000 Lumen (Gas Replica) light fixture as set forth on Appendix B, page 5 of 13, of the October 16, 2020 Order shall be revised to reflect a rate of \$23.64.

2.	All other provisions of the October 16, 2020 Order that are not in conflict
with the ter	ms of this Order shall remain in full force and effect.
