<u>ORDER</u>

On September 3, 2019, Millennium Energy, Inc. (Millennium), filed its proposed Gas Cost Recovery (GCR) rate report to be effective October 1, 2019. After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Millennium's report includes revised rates designed to pass on to its customers its expected change in gas costs.

2. Millennium's report sets out an Expected Gas Cost (EGC) of \$2.7937 per Mcf, which is a decrease of \$.4320 per Mcf from its previous EGC of \$3.2257 per Mcf.

3. Millennium's report sets out no supplier Refund Adjustment.

4. Millennium's report sets out a current quarter Actual Adjustment (AA) of (\$.0853) per Mcf. Millennium's total AA is (\$.0821) per Mcf, which is a decrease of \$.0547 per Mcf from its previous total AA of (\$.0274) per Mcf.

5. Millennium's report sets out a current quarter Balance Adjustment (BA) of (\$.0131) per Mcf. Millennium did not include the reconciliation of the expired (\$.0169) per Mcf BA previously approved in Case No. 2018-00176¹ in the calculation of its current quarter BA. Millennium's corrected current quarter BA is (\$.0157) per Mcf. Millennium's

total BA is (\$.0148) per Mcf, which is a decrease of \$.0174 per Mcf from its previous total BA of \$.0026 per Mcf.

6. Millennium's corrected GCR rate is \$2.6968 per Mcf, which is a decrease of \$.5041 per Mcf from the previous GCR rate of \$3.2009 per Mcf.

7. The rates set forth in the Appendix to this Order are fair, just, and reasonable and should be approved for service rendered by Millennium on and after October 1, 2019. Although Millennium's GCR rate report did not provide 30 days' notice to the Commission as required by its tariff, KRS 278.180(2) authorizes the Commission to make a reduction in rates effective in less than 30 days.

8. Should Millennium purchase sustainable natural gas from a renewable source during the reporting period of any future GCR reports then the supplier, cost, and amount must be documented in its cover letter to the Commission.

IT IS THEREFORE ORDERED that:

1. The rates proposed by Millennium are denied.

2. The rates set forth in the Appendix to this Order are approved for service rendered on and after October 1, 2019.

3. Within 20 days of the date of entry of this Order, Millennium shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets setting out the rates approved herein and reflecting that they were approved pursuant to this Order.

4. This case is closed and removed from the Commission's docket.
