ORDER

On September 27, 2019, Louisville Gas and Electric Company (LG&E) filed its

proposed Gas Supply Clause (GSC) application to be effective November 1, 2019.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

 LG&E's application includes revised rates designed to pass on to its customers its expected change in gas costs.

2. LG&E's application sets out a Gas Supply Cost of \$.34848 per 100 cubic feet, or \$3.4848 per Mcf, which is an increase of \$.3764 per Mcf from the previous Gas Supply Cost of \$3.1084 per Mcf.

3. LG&E's application sets out no Refund Factor.

4. LG&E's application sets out a current Gas Cost Actual Adjustment (GCAA) of (\$.0493) per Mcf and a total GCAA of \$.2945 per Mcf, which is a decrease of \$.0168 per Mcf from the previous total GCAA of \$.3113 per Mcf.

 LG&E's application sets out a Gas Cost Balance Adjustment (GCBA) of (\$.0023) per Mcf, which is a decrease of \$.0037 per Mcf from the previous GCBA of \$.0014 per Mcf. 6. LG&E's application sets out a Performance-Based Rate Recovery Component (PBRRC) of \$.0635 per Mcf, which is no change from its previous PBRRC.

LG&E's Gas Supply Cost Component (GSCC) is \$.38405 per 100 cubic feet
or \$3.8405 per Mcf, which is an increase of \$.3559 per Mcf from the prior GSCC of
\$3.4846 per Mcf.

8. The rate as proposed by LG&E and set forth in the Appendix to this Order is fair, just, and reasonable, and should be approved for gas supplied by LG&E on and after November 1, 2019.

IT IS THEREFORE ORDERED that:

1. The rate proposed by LG&E and set forth in the Appendix to this Order is approved for gas supplied by LG&E on and after November 1, 2019.

2. Within 20 days of the date of entry of this Order, LG&E shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets setting out the rate approved herein and reflecting that it was approved pursuant to this Order.

3. This case is closed and removed from the Commission's docket.
