## ORDER

On September 29, 2019, Peoples Gas KY, LLC (Peoples), filed its proposed Gas Cost Recovery (GCR) rate report to be effective November 1, 2019. On October 11, 2019, Peoples filed a supplemental GCR report correcting a record error for the supply cost presented for each month.<sup>1</sup> The correction does not affect the rate calculation, as the total supply cost listed remains the same.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

- Peoples' GCR report includes a revised rate designed to pass on to its customers its expected change in gas costs.
- Peoples' GCR report sets out an Expected Gas Cost (EGC) of \$4.0231 per
  Mcf, which is an increase of \$.3657 per Mcf from its previous EGC of \$3.6574 per Mcf.
  - Peoples' GCR report sets out no Refund Adjustment.
- 4. Peoples' GCR report sets out a current quarter Actual Cost Adjustment (ACA) of \$.1124 per Mcf. Peoples' total ACA is (\$.2574) per Mcf, which is a decrease of \$.2261 per Mcf from the previous total ACA of (\$.0313) per Mcf.

- Peoples' GCR report sets out a current quarter Balance Adjustment (BA) of \$.0387 per Mcf. Peoples' total BA is \$.0396 per Mcf, which is an increase of \$.0534 per Mcf from the previous total BA of (\$.0138) per Mcf.
- Peoples' GCR rate is \$3.8053 per Mcf, which is an increase of \$.1930 per
  Mcf from its previous rate of \$3.6123 per Mcf.
- 7. The rate as proposed by Peoples and set forth in the Appendix to this Order is fair, just, and reasonable, and should be approved for final meter readings by Peoples on and after November 1, 2019.

## IT IS THEREFORE ORDERED that:

- The rate proposed by Peoples and set forth in the Appendix to this Order is approved for final meter readings on and after November 1, 2019.
- Within 20 days of the date of entry of this Order, Peoples shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets setting out the rate approved herein and reflecting that it was approved pursuant to this Order.
  - 3. This case is closed and removed from the Commission's docket.
