ORDER

On September 27, 2019, Delta Natural Gas Company, Inc. (Delta), filed its proposed Gas Cost Recovery (GCR) report to be effective October 28, 2019.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Delta's GCR report includes revised rates designed to pass on to its customers its expected change in gas costs.

2. Delta's GCR report sets out an Expected Gas Cost (EGC) of \$3.4638 per Mcf, which is a decrease of \$1.0574 per Mcf from the previous EGC of \$4.5212 per Mcf.

3. Delta's GCR report sets out no Refund Adjustment.

4. Delta's GCR report sets out a current quarter Actual Adjustment (AA) of \$.0932 per Mcf. Delta's total AA is \$1.1312 per Mcf, which is an increase of \$.3841 per Mcf from the previous total AA of \$.7471 per Mcf.

Delta's GCR report sets out a current quarter Balance Adjustment (BA) of
\$.0108 per Mcf. Delta's total BA is (\$.2625) per Mcf, which is a decrease of \$.0281 per
Mcf from the previous BA of (\$.2344) per Mcf.

6. Delta's GCR rate is \$4.3325 per Mcf, which is a decrease of \$.7014 per Mcf from the previous GCR rate of \$5.0339 per Mcf.

7. The rates as proposed by Delta and set forth in the Appendix to this Order are fair, just, and reasonable and should be approved for final meter readings by Delta on and after October 28, 2019.

IT IS THEREFORE ORDERED that:

1. The rates proposed by Delta and set forth in the Appendix to this Order are approved for final meter readings on and after October 28, 2019.

2. Within 20 days of the date of entry of this Order, Delta shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets setting out the rates approved herein and reflecting that they were approved pursuant to this Order.

3. This case is closed and removed from the Commission's docket.
