<u>ORDER</u>

On September 1, 2020, Community Action Kentucky, Inc. (CAK) filed a motion requesting an extension of time until September 15, 2020, to file executed contracts with subcontracting agencies that will administer ratepayer-funded home energy assistance (HEA) programs offered by utilities that are parties to this proceeding. Pursuant to deadlines established in a Commission Order issued May 4, 2020, CAK was to have filed the contracts with the Commission on September 2, 2020.

As a basis for the motion, CAK stated that it is awaiting approval from the utilities of a draft utility contract template. CAK explained that it must first obtain the utilities' approval before submitting the contract template for Commission approval and executing the contracts with the subcontracting agencies. CAK expects that it will obtain the utilities' approvals and execute the contracts on or before September 15, 2020.

Based upon a review of the motion, the Commission finds that CAK established good cause to grant the motion and that the extension will not result in undue prejudice to any party to this proceeding.

IT IS THEREFORE ORDERED that:

1. CAK's motion for an extension is granted.

2. CAK shall file the executed contracts with subcontracting agencies on or before September 15, 2020.
