COMMISSION STAFF'S FIRST REQUEST FOR INFORMATION  
TO GREEN RIVER VALLEY WATER DISTRICT

Green River Valley Water District (Green River Valley District), pursuant to 807 KAR 5:001, is to file with the Commission an electronic version of the following information. The information requested herein is due on September 15, 2020. Pursuant to the Commission's Orders in Case No. 2020-00085,<sup>1</sup> issued March 16, 2020, and March 24, 2020, Green River Valley District SHALL NOT FILE the original paper copy of all requested information at this time, but rather shall file original paper copies within 30 days of the lifting of the current state of emergency. All responses in paper medium shall be appropriately bound, tabbed, and indexed. Electronic documents shall be in portable document format (PDF), shall be searchable, and shall be appropriately bookmarked.

Each response shall include the name of the witness responsible for responding to the questions related to the information provided. Each response shall be answered

under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or the person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

Green River Valley District shall make timely amendment to any prior response if Green River Valley District obtains information that indicates the response was incorrect when made or, though correct when made, is now incorrect in any material respect. For any request to which Green River Valley District fails or refuses to furnish all or part of the requested information, Green River Valley District shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.

Careful attention shall be given to copied material to ensure that it is legible. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request. When applicable, the requested information shall be separately provided for total company operations and jurisdictional operations. When filing a paper containing personal information, Green River Valley District shall, in accordance with 807 KAR 5:001, Section 4(10), encrypt or redact the paper so that personal information cannot be read.

1. Refer to Green River Valley District's Offer of Settlement filed August 25, 2020.

a. State the basis for the estimated cost of the proposed project; provide all workpapers used to arrive at the \$110,000 estimated cost.

b. Provide copies of all opinions or studies, including the initial hydraulic calculations that Green River Valley District relied upon when determining this construction project would address the low water pressure problem that is the subject of this complaint.

c. State how Green River Valley District will fund the construction project.

3. State whether Ms. Sanders has agreed to the settlement proposal. If not, provide a status update on the settlement negotiations.

4. State how Green River Valley District is currently addressing the low water pressure issue at Ms. Sanders's residence and how Green River Valley District plans to address the low water pressure issue until construction of the pumping station is completed.

5. State the estimated annual cost to operate the proposed pumping station.

6. Provide the hydraulic analysis, engineering plans and specifications, and application submitted to the Division of Water in connection with this proposed construction.
