### ORDER

On October 21, 2019, Muhlenberg County Water District No. 3 (Muhlenberg District #3) applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.<sup>1</sup>

Having reviewed the record and being otherwise sufficiently advised, the Commission finds that:

- Muhlenberg District #3 purchases water from the city of Central City
  (Central City).
- 2. The city of Central City (Central City) notified Muhlenberg District #3 that its wholesale rate would increase from \$2.63 per 1,000 gallons to \$3.31 per 1,000 gallons effective July 31, 2019. Muhlenberg District #3 proposes to increase the water rates to its customers effective October 31, 2019, to reflect the increased cost of purchased water from Central City.
- 3. Muhlenberg District #3 proposed a purchased water adjustment factor of \$0.88 per 1,000 gallons in its application.

- 4. During the 12 months ended August 31, 2019, Muhlenberg District #3 purchased 213,989,900 gallons of water from Central City. During the same period, Muhlenberg District #3 sold 166,778,900 gallons of water. The increase in the cost of purchased water is \$145,513.13, resulting in a purchased water adjustment factor of \$0.88 per 1,000 gallons.
- 5. The purchased water adjustment factor of \$0.88 per 1,000 gallons, as calculated in Appendix A to this Order, is fair, just, and reasonable and should be approved.
  - 6. Muhlenberg District #3's proposed rates are approved.
- 7. Muhlenberg District #3 proposed an effective date of October 31, 2019, Central City's wholesale rate to Muhlenberg District #3 was approved for service provided effective November 19, 2019.<sup>2</sup>
- 8. The rates as set forth in Appendix B to this Order are fair, just, and reasonable, and should be approved for water service rendered by Muhlenberg District #3 on and after November 19, 2019.

#### IT IS THEREFORE ORDERED that:

- 1. The purchased water adjustment factor of \$0.88 per 1,000 gallons is approved.
  - 2. The rates proposed by Muhlenberg District #3 are approved.
  - Muhlenberg District #3's proposed effective date is denied.
- 4. The rates, as set forth in Appendix B to this Order, are approved for water service rendered by Muhlenberg District #3 on and after November 19, 2019.

  - 6. This case is hereby closed and removed from the Commission's docket.
