Request for a Pass Through Rate Adjustment

To whom it may concern,

This letter is in reference to the application for the Harrison County Water Association, Inc. (application) for Request of a Pass-Through Rate Adjustment which is fully incorporated in the application. This letter certifies, to the best of my knowledge, the following:

- A. The Harrison County Water Association purchases water from the City of Cynthiana, Kentucky; the city of Paris; and Kentucky American Water.
- B. The total amount of water purchased for the twelve months (i.e. September 2018 to August 2019) prior to the ninety (90) days of the requested rate pass through adjustment (i.e. November 15, 2019 to December 15, 2019, billing on or about January 1-5, 2020) is identified in Exhibit "A", which is fully incorporated herein, as if written word for word herein.
- C. The City of Cynthiana is the largest supplier of water to the Harrison County Water Association, Inc.'s, water distribution system. See. Exhibit "A" which establishes all of the 12 month total utility water purchase, with each entity per month.
- D. The City of Cynthiana passed a new rate for purchase of water to its existing contract between the City of Cynthiana and the Harrison County Water Association, Inc.; the new rate changes the previous purchase rate from \$2.85 per 1,000 gallons to \$3.15 per 1,000 gallons; a \$0.30 increase per \$1,000.00 gallons.; which was approved by the Kentucky Public Service Commission on July 1, 2019, pursuant to 807 KAR 5:011. See. Exhibit "E", Copy of the approved new rate.
