NOTICE OF INTENT TO FILE APPLICATION

- Big Rivers Electric Corporation ("Big Rivers"), pursuant to 807 KAR
 5:120 Section 1, respectfully submits this notice of its intent to file an application for a certificate of public convenience and necessity to construct a 345 kV
 transmission line in Meade County, Kentucky.
- 2. The name, address, telephone number, and electronic mail address of the applicant are:

3. The proposed construction consists of a new 345 kV transmission line in Meade County, Kentucky. This new transmission line will extend 2.7 miles north from a new switching station (the Redmon Switching Station) in Ekron, Kentucky, to a new substation (the Otter Creek Substation) in Garrett, Kentucky.

The main purpose of the proposed transmission line is to serve the Nucor Brandenburg Steel Mill, which will be located approximately 1.5 miles east of Brandenburg, Kentucky. The transmission line will supply power to the Brandenburg Steel Mill via the Otter Creek Substation.

- 4. The Otter Creek Substation is one of the projects that is the subject of Big Rivers' application in Case No. 2019-00270. It is listed as Project D in that application. The proposed transmission line and the Redmon Switching Station that are the subject of this notice are discussed as Projects F and G in the application in Case No. 2019-00270.
- 5. A 125 ft. wide easement will be required for the proposed transmission line. It will typically be constructed using steel monopole structures for tangent structures, and three-pole steel structures for angle structures and large angled dead-end structures. 807 KAR 5:120 Section 2(b).
- 6. The proposed transmission line will be located entirely in Meade County, Kentucky. 807 KAR 5:120 Section 2(c).
