ORDER

On November 20, 2019, Boone County Water District (Boone District) applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.¹

Having reviewed the record and being otherwise sufficiently advised, the Commission finds that:

- Boone District purchases water from the Boone-Florence Water
 Commission (Boone-Florence).
- 2. Boone-Florence notified Boone District that its wholesale rate would increase from \$3.39 per 1,000 gallons to \$3.49 per 1,000 gallons effective January 1, 2019. Boone District proposes to increase the water rates to its customers effective December 31, 2019, to reflect the increased cost of purchased water from Boone-Florence.
- 3. Boone District proposed a purchased water adjustment factor of \$0.11 per 1,000 gallons in its application.
- 4. During the 12 months ended September 30, 2019, Boone District purchased 2,929,508,190 gallons of water from Boone-Florence. During the same period, Boone

District sold 2,619,007,486 gallons of water. The increase in the cost of purchased water is \$292,950.82, resulting in a purchased water adjustment factor of \$0.12 per 1,000 gallons.

- 5. In its application, Boone District miscalculated the purchased water adjustment factor.
- 6. The purchased water adjustment factor of \$0.12 per 1,000 gallons, as calculated in Appendix A to this Order, is fair, just, and reasonable and should be approved.
 - 7. Boone District's proposed rates are denied.
- 8. The rates as set forth in Appendix B to this Order are fair, just, and reasonable, and should be approved for water service rendered by Boone District on and after December 31, 2019.

IT IS THEREFORE ORDERED that:

- The purchased water adjustment factor of \$0.12 per 1,000 gallons is approved.
 - 2. The rates proposed by Boone District are denied.
- The rates as set forth in Appendix B to this Order are approved for water service rendered by Boone District on and after December 31, 2019.
- 4. Within 20 days of the date of entry of this Order, Boone District shall file with the Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets showing the rates approved herein.
 - 5. This case is hereby closed and removed from the Commission's docket.
