## ORDER

On November 27, 2019, LaRue County Water District No. 1 (LaRue District No. 1) applied for approval to adjust its rates pursuant to the purchased water adjustment procedure. LaRue District No. 1 amended its application on December 5, 2019, stating the original filing was incorrect.

Having reviewed the record and being otherwise sufficiently advised, the Commission finds that:

- 1. LaRue District No. 1 purchases water from the city of Campbellsville (Campbellsville), Green-Taylor Water District (Green-Taylor District), the city of Bardstown (Bardstown), the city of New Haven (New Haven), Green River Valley Water District (Green River Valley District), and the city of Hodgenville (Hodgenville).
- 2. Bardstown notified LaRue District No. 1 that its wholesale rate would increase from \$2.00 per 1,000 gallons to \$2.45 per 1,000 gallons effective January 1, 2020. LaRue District No. 1 proposes to increase the water rates to its customers effective January 1, 2020, to reflect the increased cost of purchased water from Bardstown.

- 3. LaRue District No. 1 proposed a purchased water adjustment factor of \$0.08 per 1,000 gallons in its amended application.
- 4. During the 12 months ended November 30, 2019, LaRue District No. 1 purchased 13,092,300 gallons of water from Campbellsville, 3,210,900 gallons of water from Green-Taylor District, 26,476,000 gallons of water from Bardstown, 11,393,000 gallons of water from New Haven, 95,147,200 gallons of water from Green River Valley District, and 41,353,000 gallons of water from Hodgenville. During the same period, LaRue District No. 1 sold 166,764,571 gallons of water. The increase in the cost of purchased water is \$11,914.20, resulting in a purchased water adjustment factor of \$0.08 per 1,000 gallons.
- 5. The purchased water adjustment factor of \$0.08 per 1,000 gallons, as calculated in Appendix A to this Order, is fair, just, and reasonable and should be approved.
- 6. The rates, as set forth in Appendix B to this Order, are fair, just, and reasonable, and should be approved for water service rendered by LaRue District No. 1 on and after January 1, 2020.

### IT IS THEREFORE ORDERED that:

- 1. The purchased water adjustment factor of \$0.08 per 1,000 gallons is approved.
- 2. The rates, as set forth in Appendix B to this Order, are approved for water service rendered by LaRue District No. 1 on and after January 1, 2020.

- 3. Within 20 days of the date of entry of this Order, LaRue District shall file with the Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets showing the rates approved herein.
  - 4. This case is hereby closed and removed from the Commission's docket.
