## ORDER

On February 7, 2020, Kentucky Power Company (Kentucky Power) filed a motion, pursuant to 807 KAR 5:058, Section 10, requesting to deviate from requirements to publish notice of its Integrated Resource Plan (IRP) within 30 days of filing the IRP.

As a basis for its motion, Kentucky Power stated that it filed its IRP on December 20, 2019, and thus Commission regulations required Kentucky Power to publish notice of the filing on or before January 19, 2020. Kentucky Power further stated that it timely provided the required notice to Kentucky Press Service, Inc. (Kentucky Press Service), which arranged for publication of notice on or before January 19, 2020, in 20 newspapers in Kentucky Power's service territory. Kentucky Power explained that *Grayson Journal* failed to publish notice as scheduled and instead published notice on January 29, 2020. Kentucky Power stated that it was not informed why publication was delayed. Along with the motion, Kentucky Power filed notarized proof of publication from Kentucky Press Service that all newspapers published the notice between January 7 and January 10, 2020, with the exception of *Grayson Journal*, which published notice on January 29, 2020.

The Commission, being otherwise sufficiently advised, finds that Kentucky Power established good cause to deviate from 807 KAR 5:058, Section 10, because it timely provided the required notice to the Kentucky Press Service as evidenced by the fact that

19 of 20 newspapers timely published the notice, and the delay in publishing notice in the *Grayson Journal* appears to rest with *Grayson Journal* and not Kentucky Power. Therefore, the motion should be granted.

IT IS HEREBY ORDERED that Kentucky Power's motion to deviate from the notice of publication requirement in 807 KAR 5:058, Section 10, is granted.
