3. Pursuant to KRS 278.360 and 807 KAR 5:001, Section 9(9), a digital video transcript shall be made of the hearing.

4. The hearing shall be held by videoconference. Commission Staff shall contact counsel for the parties by electronic mail to provide details for joining the videoconference.
