Pursuant to a Staff Notice issued on October 7, 2020, a video informal conference (“IC”) was conducted on November 2, 2020. Attached is a copy of the attendance roster.

The purpose of the IC was to discuss Integrated Resource Planning (IRP) modeling and related issues presented in this matter.

Kentucky Power reviewed its IRP process and provided a demonstration of Plexos modeling. Kentucky Power indicated no confidential information was included in the Power Point presentation it presented and that the slides from the presentation would be made available to Staff.
