ORDER

By Order dated October 7, 2020, the Commission scheduled a hearing to be held in this matter on Thursday, December 10, 2020, at 9 a.m. Eastern Standard Time, in the Richard Raff Hearing Room (Hearing Room 1) at the offices of the Public Service Commission at 211 Sower Boulevard, Frankfort, Kentucky. The Commission anticipates receiving testimony on the following topics: transmission, including costs, constraints, and renewables; the Rockport exit and coverage of load; demand-side management programs; Industrial Green Power tariffs and economic development rates; and the impact of environmental regulation.

In addition, the Commission finds that Kentucky Power Company (Kentucky Power) should file with the Commission a list identifying the witnesses who will offer testimony on behalf of Kentucky Power by December 4, 2020. The Commission directs Kentucky Power to follow the filing procedures outlined in the March 16, 2020 and March 24, 2020 Orders in Case No. 2020-00085.¹
