My home has a Ewing mailing address, but is just barely outside the Flemingsburg city limit, only 0.4 miles from the High School. My home is in one of the nicest subdivisions in Fleming County. The proposed solar farm will go behind and around several homes in my subdivision and will lower the value of every home in it. There are about one dozen homes that range from \$250k to \$300k in value. In addition, the proposed solar farm will be on prized farm land. If this project goes forward, but then fails, valuable farm land will have been rendered useless and an ugly eyesore will be there for decades. On top of that, the citizens of Fleming County will be on the hook for the \$191m grant/loan. I've been told that any power generated would be sold along the East coast. Why should Fleming County KY give up beautiful farm land for citizens along the East coast who stand to benefit, but have to assume no risk.
