

My name is Teresa Kay Cheek, and I live at 970 Lamastus Road in Reynolds Station, KY

which is in Hancock County. I was the last of 15 at my job to be able to begin working from home 11 years ago because I had no access to internet at home in Hancock County. I was able to join some neighbors to speak with ConnectGradd and begin a petition which did result in our getting a tower in Boling Chapel area. The problem was that service was not very dependable. The addition of too many customers along with outdated equipment took its toll so I have had some satellite internet providers before now having a "hot spot". Connectgradd began as a project to help rural areas, but even they focus more on populated areas. Having dependable service (no matter the weather ) that would allow better service such as streaming, gaming,etc. would be wonderful.

My children also struggled with school work prior to my having what internet service I could get. My son Logan moved to Owensboro only because he couldn't deal with my internet service. He plays games online while talking to high school and college buddies to keep in touch after graduating. He also likes to invest in stocks and also works from home during COVID-19. Logan said everything he does involves the internet.

Please allow Kenergy to provide customers internet because no other company is going to invest in our area. Hancock County residents and officials have tried to bring in internet providers for years. Kenergy already has electric poles to run the service, and they are a reliable company. Please consider all the times each of you use the internet during the day. What if you needed to look up something but there was a cloud that left you without service?
