To Whom it May Concern:

We are the affected property owners and are requesting an intervention in case# 2020-00290 -Bluegrass Water Utility Operating Company / Woodland Acres.

We received a letter dated November 19, 2020 from the Bluegrass Water Utility Operating Company (See attached) concerning the wastewater services in our community. The letter states that they are requesting a 393.8% increase in our sewer bill! The same month LG&E submitted a rate increase to the Public Service Commission of 11.6% and every news station in the area covered the outrage of the LG & E customers at this huge increase!

To ask for this kind of increase in what is clearly a low income area is outrageous and would cause undo hardship and stress to the property owners. Many would simply be unable to absorb this large of a rate increase and would become delinquent in their bills.

Woodland acres is a mobile home park where people own the lot their home sits on. The majority of people in woodland acres are on some kind of public assistance, disability or social security fixed income. To add an additional \$76.67 a month sewer bill, will make the new bill \$96.14. So you are asking people with an average income of less than \$1000 a month to do without basic necessities so Bluegrass Water to make more money?

This pandemic has hurt everyone. We know that there were bad decisions made concerning the waste water treatment plants in the area. But those decisions were made by the companies who operated them. Bluegrass knew those situations when they acquired them. The burden of those bad decisions can not rest solely on the low income residents who had no say in any of it!

If as Bluegrass suggests, the expense of the upgrades they have decided to do should be passed along to the consumers, and you as the Public Service Commission choose to agree with then, then these increases must be added in a slow and methodical manner, over several years. Certainly not all at once, in a year with a pandemic! We have suffered enough.

We as the below listed property owners of Woodland Acres, establishing both our status and interest as interested parties, and having establishing the grounds for this request, at this time formally request an intervention in this proceeding by the Public Service commission.

Dear Potential Bluegrass Customer:

We're writing to you about the wastewater services in your community.

Bluegrass Water Utility Operating Company, LLC (Bluegrass Water) has asked the Kentucky Public Service Commission (Commission) to acquire the system that serves your community. The Commission case number for that application is 2020-00297.

On September 30, 2020, Bluegrass Water submitted to the Commission a request for a general adjustment of rates charged for service. The request seeks to increase annual sewer operating revenues by \$2,177,052 (Case # 2020-00290). Since last year, Bluegrass Water has invested nearly \$2.5 million in urgently needed improvements in the Kentucky communities it serves to ensure access to clean, safe and reliable drinking water and wastewater systems. Over the next 18 months, Bluegrass Water intends to invest approximately \$5 million more in its Kentucky systems to ensure they are able to provide safe and reliable service. Increased costs attributable to these and other improvements make it necessary to seek a rate increase at this time.

Because the Commission has not yet ruled on either the acquisition or rate increase requests, there will be NO CHANGE in your billing at this time and you should continue to pay your current service provider for the service you receive. Any future change in the rates you are charged must first be approved by the Commission.

Please take notice of the following information about the proposed rate adjustment that is described below and presented on the enclosed table:

The table compares current rates for communities served by Bluegrass Water to the increased rates the company is requesting and shows the proposed increases as both a percentage and a dollar amount. The Commission, the state agency that regulates all utility services in Kentucky, will rule on this request and may order rates to be charged that differ from the proposed rates found in this notice. The average customer usage is unknown and the average bill in each service area relates directly to the current rates per month shown in the enclosed sheet. The date the proposed rates were filed with the Commission was September 30, 2020, with a proposed effective date of October 30, 2020. On October 30, 2020, the Commission suspended the proposed rates for six months while it reviews the application. As a result, the proposed rates will not go into effect before May 1, 2021.

By prior arrangement, you may examine Bluegrass Water's application at the offices of McBrayer PLLC, 201 East Main Street, Suite 900, Lexington, Kentucky. Please contact Bluegrass Water at 1-866-752-8982 to arrange to examine the application. Bluegrass Water's application also may be examined at the Commission's offices located at 211 Sower Boulevard, Frankfort, Kentucky, Monday through Friday, 8:00 a.m. to 4:30 p.m., or through the Commission's website at http://psc.kv.gov. Comments regarding the rate application (case # 2020-00290) or timely requests for intervention (that establish the grounds for the request, including the status and interest of the requester) may be submitted to the Commission through its website or by mail to:

If the Commission does not receive a written request for intervention establishing the grounds for the request (including the status and interest of the party) within thirty (30) days of the initial mailing of this notice, it may take final action on the application.
