To whom it may concern,

Having utilities require external, lockable disconnects with a visible open near the utility meter is expensive, wasteful and unnecessary. Given that the inverters are required to automatically

shutdown when the grid signal is lost, the disconnects are obsolete. The disconnects don't enhance safety.

As a PV system owner, the requirement increased the cost of my project about \$1000 dollars. It is analogous to requiring every GFCI socket to have an additional manual shutoff next to it.

Someone is making money selling those expensive, bulky boxes and the "little people," are paying for it. I feel this is a case in which powerful, quasi-governmental agencies that write requirements have an opportunity to actually look after the "little people," and move us into the 21st century by changing the code. It is time for the relationship between the disconnect manufacturers and utilities to change; the manufacturers need to innovate and move their products on to things people need.

I urge the PSC to end the requirement.
