Not only mine, but lots of folks here having the same problem. Please consider this as many of us have been off work and just trying to make it.

I think this inflation in Georgetown is worse than other places due to the big influx of people that have moved here lately???? I'm not sure why they're here. I'm a 74 year old female-widow, too old to look for another paying job. Please reconsider this KU rate hike and do not approve it..
