In light of the recent request for a rate increase in residential rates for gas and electric service to Louisville Kentucky of approximately 20%, it's important to note that while some of us will not be affected as much as the majority, how can you justify this increase in cost? It seems to be a never ending train of increases across the board, with no end in sight.

Just last year alone, our MSD sewer expenses increased as well. I am single with no kids, and my MSD sewer expenses are over \$135 for three months. I hardly use any water compared to a family of four or more. That is an increase of almost \$35 over three months, Since 2014, when I bought this house. That is an additional \$105 a year, plus whatever tax is required.

The additional 20% tacked onto monthly utility bills, Will increase my monthly expense by anywhere from \$24 per month, to \$58 per month depending on the time of year. And certainly when the winter season comes and stays colder than usual, I suspect my bill will increase by considerably more than that \$58/mth, For several months of the year.

For those approximately 3 to 4 months a year that we would use more gas, that's well over \$250 additional for just 3 to 4 months. The rest of the season, gas and electric may not be used as much - but the electricity total will be at least \$144 or more.

Therefore, my yearly expense for just electric and gas alone would increase \$395, or more. That does not include the sewer rates, at \$135 every four months.

Perhaps we should consider looking at other sources of revenue for the utility companies. Perhaps cutting back on the consistent raises for employees, slashing budgets for nonessential items, limiting new hires, new policies that promote peoples ability to do their jobs correctly and efficiently.

And finally, employees with a pension plan such as those of the utility companies, should pay more into their own plan like the rest of the working Americans do. The free ride should be over on taxpayers backs, because even the folks reading messages like this, will also see substantial increases as well.



After they announced that they would be restoring cut off dates and late fees. This alone during uncertain times is instilling plight. This will affect not only the rate payers, but fixed income, and in turn cause local Grocers to raise their rates on food to offset Louisville Gas and Electric. (See Walmart and Krogers complimentary)

For all the numerous fixed income families through out the seventy seven counties they could potentially have to choose between food or power. Kentucky has gone through enough to have something of this magnitude for a multibillion dollar company to impose farther hardships during a nationwide pandemic. This will be third rate raise in four years should this be approved.

Louisville Gas and Electric from the 2016 rates case still has not obtained approvals ,and is with AOH on four separate hearings, as well as Franklin County Court with a PSC case and Bullitt County Court. How could Louisville Gas and Electric be rewarded to allow a rates increase to pass with such negligence on a four soon to be five year project .

They also decided to switch pathways without submitting documentation to the Kentucky State Public Service- which should has triggered a new review and approvals. They are eight months to a year away to redo expired data and testing for review with the Energy and Environment Cabinet approvals on new permits for this project, as well the four separate AOH Hearings with Kentucky State and Army Core and EPA approval for all karst caves and sinkholes/ unstable soils.

When will the State of Kentucky Government Offices take a stand ,exert their authority ,and power to make Louisville Gas and Electric uphold the the law and responsibility to Kentuckians? State Government is to have the responsibility and obligation to the residence of Kentucky. Public intrest and protection is to mean more than to cater or pander for a multibillion dollar for profit utility company(economic development)

I hope that Kentucky State Public Service Commissioner does the right thing lawfully stepping in and denies Louisville Gas and Electric.
