I want to voice my complaint about several things being proposed by Louisville Gas & Electric Co. This company should be a good neighbor, instead of becoming a negative community influence.

1. Raising the residential rates by 13% during a pandemic is so stupid. Now is not the time to be extra hard on low & moderate income families who are already struggling.
2. Raising the mandatory connection fees to \$1.30 per day (\$374.50 per year) is unnecessarily high for all.
3. Charging all of us for 'smart meters' -- \$400 million cost. If they smart meters, let them pay for them at the company level.
4. Devaluing net metering -- They want to pay only 2 cents per kwh for exported electricity (from solar panels), but charge 10.5 cents per kwh for imported electricity. That really hurts the solar homeowners who are trying to help clean up our environment. And I don't even have solar; it's just not fair.
5. Their Solar Share Program is trying to sell people on paying a \$5.55 lease payment per month (per panel) to get \$2.50 per month or less in a credit on their bill. And they make it sound wonderful, and are enticing gullible people into thinking they are helping the environment.
