ORDER

The matter is before the Commission upon a motion filed by Louisville Gas and Electric Company (LG&E) and Kentucky Utilities Company (KU) requesting an extension of time to file its revised tariffs as directed in the May 8, 2020 Order in this matter. In support of their request, LG&E and KU state that the May 8, 2020 Order approved a proposed revision of the companies' Green Tariffs to permit either LG&E or KU to enter into Renewable Power Agreements (RPA) with customers under Option #3 for a system cumulative 125 MW name plat AC period and ordered LG&E and KU to submit revised tariff sheets reflecting this revision with 20 days. The May 8, 2020 Order also directed KU to submit within 20 days the RPAs with Toyota and Dow as modified by the May 8, 2020 Order.

LG&E and KU state that they intend to file a motion for rehearing regarding certain aspects of the May 8, 2020 Order. In particular, the companies inform that they will seek clarification of certain required modifications to Green Tariff Option #3 and the regulatory

treatment of the cost of energy purchased under their contract with Rhudes Creek Solar, LLC, as well as request reconsideration of other provisions of the May 8, 2020 Order.

LG&E and KU assert that the filing of revised Green Tariff Option #3 should be delayed pending a decision on the companies' rehearing request. The companies also advise that the parties to the Toyota and Dow RPAs plan no action to implement those RPAs until a decision is issued on the companies' upcoming rehearing request and clarified certain portions of the May 8, 2020 Order. LG&E and KU state that the submission of revised tariff sheets before these uncertainties are resolved serves no useful purpose and would result in unproductive expenditure of resources. Accordingly, LG&E and KU request an extension of time to file the revised tariff sheets and modified RPAs with Toyota and Dow to 20 days following the issuance of an Order addressing the companies' rehearing request.

Having reviewed the motion and being otherwise sufficiently advised, the Commission finds that LG&E and KU's motion for an extension of time to file their revised Green Tariffs and the modified Toyota and Dow RPAs is reasonable and should be granted.

IT IS THEREFORE ORDERED that:

- 1. LG&E and KU's motion for an extension of time is granted.
- 2. The period in which LG&E and KU shall file their revised Green Tariff Option #3 and the modified RPAs with Toyota and Dow to comply with the May 8, 2020 Order is extended to 20 days following the issuance of an Order addressing the companies' motion for rehearing.
