## ORDER

On March 23, 2020, Green River Valley Water District (Green River Valley District) filed with the Commission its reponses to Commission Staff's First Request for Information and a motion requesting a deviation from 807 KAR 5:001, Section 4(10).

As grounds for Green River Valley District's motion for deviation, Green River Valley District states that Comission Staff's First Request for Information, Request No. 1 sought a copy of all written complaints related to low water pressure; Request No. 2 sought the name, address, and other pertinent information of customers who had individual pumps installed to their water services; and Request No. 9 requested the name and address of each customer whose water service pressure is less than 30 pounds per square inch. In its responses, Green River Valley District submitted a copy of each work order addressing a complaint regarding low pressure. Each work order contained the name, address, telephone number, and account number of the complaining customer. Green River Valley District's responses also provided the names and addresses requested by Request Nos. 2 and 9. Green River Valley District states that, to the best of its knowledge and good faith belief, the information contained in its responses to Request Nos. 1, 2, and 9 are necessary to assist the Commission in its review of the

proposed tariff, and redaction of information would frustrate the purpose for which the information was requested. Green River Valley District also states that the unredacted information will not allow any person to access the customers' water accounts or take any action regarding the accounts, nor will it enable any person access to any financial amount.

Having reviewed the record, the Commission finds that Green River Valley District's motion for a deviation from 807 KAR 5:001, Section 4(10) should be granted.

## IT IS HEREBY ORDERED that:

- Green River Valley District's Motion for Deviation from 807 KAR 5:001,
   Section 4(10), is granted.
- 2. The Commission accepts Green River Valley District's March 23, 2020 responses to Commission Staff's First Request for Information in its current, unredacted form.
